ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, acting as sole incorporator of **SOUTHLAKE RESIDENTIAL DESIGN, INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation shall be **SOUTHLAKE RESIDENTIAL DESIGN, INC.**

Shares

The number of shares which the corporation shall have authority to issue is Two Hundred (200), consisting of a single class of common stock, One Hundred Dollars (\$100.00) par value per share.

Initial Board of Directors



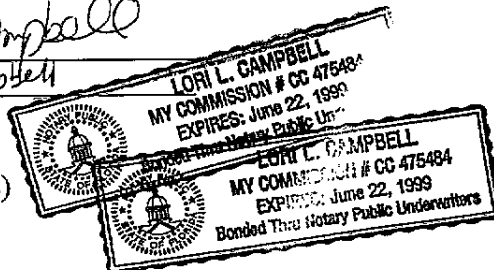
