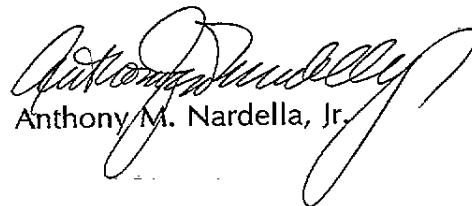

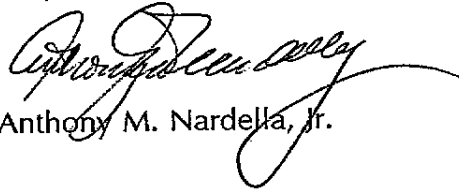

ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is H & A SERVICES, INC.

ARTICLE II

The existence of the corporation shall begin immediately upon filing with the Florida Department of State.

ARTICLE III

The street address of the principal office of the Corporation is 9665 N.W. 76th Court, Tamarac, Florida 33321.

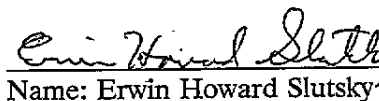
ARTICLE VIII

ARTICLE IX

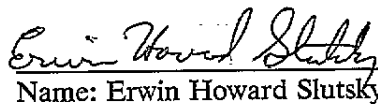
The private property of the shareholders shall not be subject to payment of the Corporation's debts to any extent.
