ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

Pursuant to the provisions of § 607.1003, Florida Statutes, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Article IV of the Articles of Incorporation is amended to reflect the following change: The corporation shall be authorized to issue up to 20,000 shares of common stock at \$1.00 par value. No other classes of stock shall be authorized.

SECOND: The amendment was adopted by the Board of Directors on the 14th day of June, 1999.

FOURTH: The above amendment was approved by unanimous written consent to resolutions by the shareholders of this Corporation on the 14th day of June, 1999.
