Pursuant to the provisions of section 607.1006, Florida Statutes, the undersigned Florida corporation adopts the following articles of amendment to its articles of incorporation.

ERLINDA PEDROSA, director of **PEDROSA ENTERPRISES, INC.**, does hereby amend the Articles of Incorporation as follows:

A. The name of the Corporation to be amended is:

PEDROSA ENTERPRISES, INC.

B. The Amendments to be adopted were unanimously approved and adopted at a duly called meeting of the board of directors held on December 15, 1997 without shareholder action.
