ARTICLES OF INCORPORATION OF SHEILA A. BISHOP-O'DEA, P.A.

The undersigned incorporator to these article of incorporation, being duly licensed to practice real estate as a salesperson under the laws of the State of Florida, with the intention of forming a professional corporation under the Florida Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, and under the laws of the State of Florida, adopts the following articles of incorporation for the corporation.

ARTICLE 1: CORPORATE NAME

ARTICLE II. PRINCIPAL OFFICE
