#### ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

#### ARTICLE I

# Name and Principal Place of Business

The name of the corporation is Burrough Sports Agency, Inc., and the principal place of business is 7632 Las Palmas Way, Jacksonville, Florida 32216.

#### ARTICLE II

### Duration
