#### ARTICLES OF INCORPORATION

OF

### AUTOS'N'PHOTOS, Inc.

The undersigned, acting as incorporator of AUTOS'N'PHOTOS, Inc., under the Florida General Corporation Act, adopts the following Articles of Incorporation.

#### ARTICLE I. NAME AND PRINCIPAL OFFICE

AUTOS'N'PHOTOS, Inc. 5666 Gardens Drive Sarasota, Florida 34243

### ARTICLE II. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

### ARTICLE III. DURATION

The corporation will have a perpetual existence.

### ARTICLE IV. PURPOSE

The general purpose or purposes for which the corporation is organized are as follows:

(a) To engage in every aspect and phase of photography and sales of automobiles including antique and rare automobiles and all other lawful businesses.

(b) To transact any or all other lawful business for which a corporation may be incorporated under the Florida General Corporation Act.

# ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 1000 shares of common stock having a par value of \$ 1 per share. The consideration to be paid for each share shall be fixed by the board of directors and may be paid in whole or in part in cash or other property, tangible or intangible, or in labor or services actually performed for the corporation, with a value, in the judgment of the directors, equivalent to or greater than the full par value of the shares.

## ARTICLE VI. PREEMPTIVE RIGHTS

Each holder of common stock of this corporation shall have the first right (subject to adjustments to avoid the issue of fractional shares) to purchase shares of common stock of this corporation that from time to time may be issued (whether or not presently authorized), including shares from the treasury of the corporation, in the ratio that the number of shares of common stock held at the time of the issue bears to the total number of shares of common stock outstanding. This right is waived by any holder of common stock who does not exercise it and pay for the stock preempted within thirty days of his receipt of a written notice from the corporation inviting him to exercise the right. A holder of common stock shall not have, solely because of his holdings of

common stock, a right to purchase shares of preferred stock that may be issued.

A holder of preferred stock shall not have, solely because of his holdings of preferred stock, a right to purchase shares of any class that may be issued by the corporation.

# ARTICLE VII. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 5666 Gardens Drive, Sarasota County, Sarasota, Florida 34243, and the name of the corporation's initial registered agent at that address is Michael Moran.

# ARTICLE VIII. INITIAL BOARD OF DIRECTORS

The corporation shall have one (2) directors initially. The number of directors may be either increased or diminished from time to time, as provided in the bylaws, but shall never be less than one. The names and street addresses of the initial director is:
