
1. Article I is hereby restated as follows:

The name of this Corporation shall be M. A. Stafford, Inc.



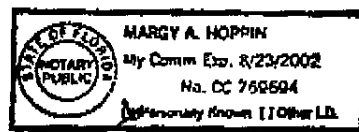
