of

The undersigned person(s), acting as incorporator(s) of a corporation organized under the laws of Florida, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I
CORPORATE NAME

The name of this corporation is A B N Venture, Inc..

ARTICLE II
TERM OF EXISTENCE

This corporation shall begin existence upon the filing of the Articles of Incorporation by the Secretary of State and shall exist perpetually.

ARTICLE III
