4. The registered agent of the corporation is Corey McCarragher and the registered street address is 7050 North Palafox Street, Pensacola, Florida 32503

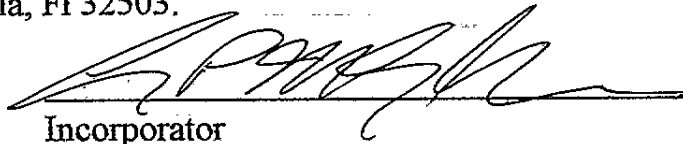
5. The initial Board of Directors shall have 1 member whose name and address is as follows:

6. The incorporator of this corporation is Corey McCarragher whose street address is 7050 North Palafox Street, Pensacola, FL 32503.

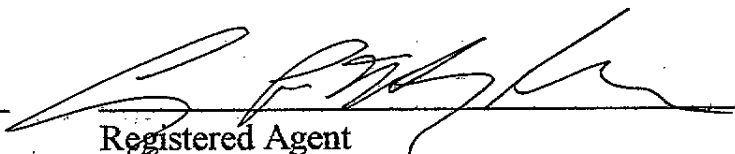
