ARTICLES OF INCORPORATION

of

The undersigned, for the purpose of forming a corporation under the FLORIDA GENERAL CORPORATION ACT, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is:

Mosquito Lagoon, Inc..

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on December 9, 1997.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of No Par Value voting common stock which shall be designated "Voting Common Stock" and 100 shares of No Par Value non-voting common stock which shall be designated "Non-Voting Common Stock". Except for voting rights, the stock shall be identical.

ARTICLE V - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash or equivalent of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof even if it requires the issuance of fractional shares, at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED AGENT

The street address of the initial registered agent's office of this corporation is 7033 S. Atlantic Ave., New Smyrna Beach, FL 32169, County of Volusia, and the name of the initial registered agent of this corporation is Paul K. Meyerhoff.

This corporation shall have one (1) Director constituting the initial Board of Directors. The number of Directors may be either increased or decreased from time to time as set forth in the By-laws. The name and address of the initial member of the Board of Directors is **Paul K. Meyerhoff, 7033 S. Atlantic Ave., New Smyrna Beach, FL 32169.**

ARTICLE VIII - INCORPORATORS

ARTICLE IX - INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent allowed by law.

ARTICLE XI - AMENDMENT

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.


