

## ARTICLES OF INCORPORATION OF SUNCOAST INSURANCE CENTER, INC.



The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: SUNCOAST INSURANCE CENTER, INC., and the address is: 2196 Princeton Street, Sarasota, FL 34237.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purpose. The general purposes for which the Corporation is organized are the following:
