The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I.

NAME: The name of this corporation shall be The JM Net Group, Inc.

ARTICLE II.

ADDRESS: The mailing address of this corporation is 1533 Barcelona Street, Fort Myers, Florida 33901.

ARTICLE III.

NATURE OF BUSINESS: This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV.

CAPITAL STOCK: This corporation is authorized to issue 1000 shares of common stock. All common stock shall be identical with each other in every respect and the holders of common stock shall be entitled to one vote for each stock on all matters on which stockholders have the right to vote.

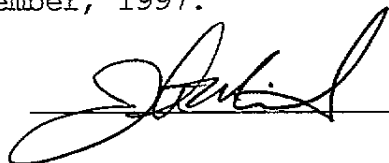
ARTICLE X.
