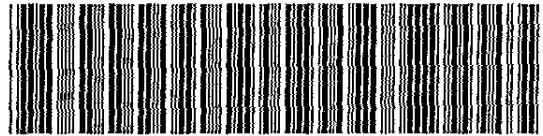

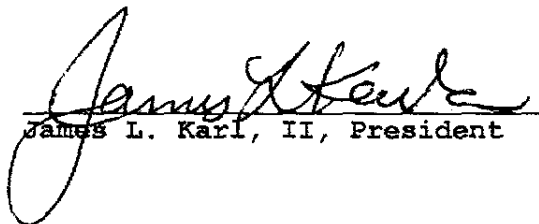

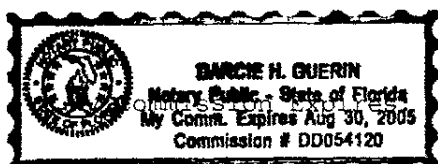
- I. The name of the corporation is: Adanac Investments, Inc.

- VII. At this time there are no actions pending against the corporation in any court.

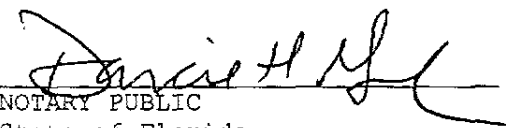
