ARTICLE I

NAME

The name of this corporation is:

Aero Shopping Corporation

### ARTICLE II

### DURATION

This Corporation is to exist perpetually. It shall commence its existence upon the signing of these Articles of Incorporation by the initial subscribers.

### ARTICLE III

## PURPOSE

This Corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States of America and the laws of the State of Florida.

### ARTICLE IV

## CAPITAL TO BEGIN BUSINESS

This Corporation is authorized to issued one hundred (100) shares at five (\$5.00) dollars par value.

Shares may be issue for such consideration as is determined from time to time by the stockholders.

Shares may not be issue until the full amount of the consideration therefor has been paid. When payment of the consideration for which shares are to be issued shall have been received by the Corporation. such shares shall be deemed to be fully paid and nonassessable.

### ARTICLE V

### PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rate share thereof (as nearly as may be done without assuance of fractional shares) at the price which is offered to others.
