I, the undersigned, desiring to form a professional association corporation for profit under the General Corporation Law of Florida, do hereby certify:

ARTICLE I

The name of the Corporation shall be: RONALD T. MAROSAN, P.A.

ARTICLE II

The Corporation shall have perpetual existence, beginning January 1, 1998.

ARTICLE III

The purposes for which said Professional Association Corporation is formed are:
