Article 1. Name

The name of this Florida corporation is:
FUTURE REHABILITATION 3, INC.

Article II. Address

Article III. Capital Stock

The Corporation shall have the authority to issue 100,000 shares of Common Stock and 100,000 shares of Preferred Stock, all of which shall have a par value of \$.001 per share.

- A. **Dividends.** The holders of Preferred Stock, prior to and in preference to any dividends or distributions to holders of Common Stock, shall be entitled to receive cash dividends at the rate of 12% of the Original Issue Price per year on each outstanding share of Preferred Stock. The Original Issue Price of the Preferred Stock shall be \$1.00 per share. The Corporation shall be obligated to pay such dividends on the Preferred Stock only when and as declared by the Corporation's Board of Directors out of legally available funds of the corporation. The dividends on the Preferred Stock shall be cumulative. After all dividends on the Preferred Stock are paid, the Board of Directors may declare dividends on the Common Stock out of legally available funds of the Corporation.
- B. **Liquidation.** Upon any liquidation, dissolution or winding up of the corporation, whether voluntary or involuntary, before any distribution shall be made to the Common stock, the holders of the sum of (a) the Original Issue Price and (b) all accrued and unpaid dividends on each share of Preferred Stock, the remaining assets of the Corporation shall be Distributable pro rata to the holders of Common Stock.
- C. **Redeem.** The Corporation may redeem some or all of the Preferred Stock at any time by written notice to the holder and payment of the sum of (a) the Original Issue less than all of the Preferred Stock shall have no voting rights.
- D. **Voting Rights.** Each share of Common Stock shall be entitled to one vote. The holders of Common Stock may cumulate their votes for directors. The shares of Preferred Stock shall have no voting rights.
- E. **Preemptive Rights.** The Corporation elects to have preemptive rights.




