The undersigned subscribes to these Articles of Incorporation for the purpose of forming a corporation under Chapter 607, Florida Statutes, as amended, and certifies as follows:

ARTICLE I - NAME

The name of the corporation shall be CLASSIC TRAVEL NETWORK, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the State of Florida, Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as it now exists or may hereafter be amended.

ARTICLE IV - CAPITOL STOCK

This corporation shall have a Board of Directors consisting of not less than one (1) nor more than 5 (5) Directors.


ARTICLE VII


