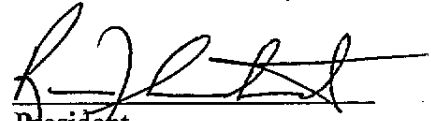
ARTICLE 1 – Name, is amended to read as follows:

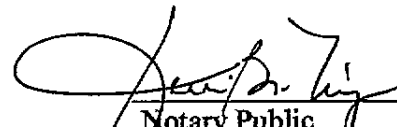
