ARTICLE I. CORPORATE NAME

The name of this Corporation is TIMELESS ADVENTURES GYM, INC.

ARTICLE II. CORPORATE PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III NATURE OF BUSINESS
