ARTICLE I - NAME

The name of this corporation is CROCKETT'S BODY THERAPY & NATURAL MEDICINE, INC. The principal address of this corporation is 900 RIVER REACH DRIVE, APT. #407, FT. LAUDERDALE, FL 33315.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

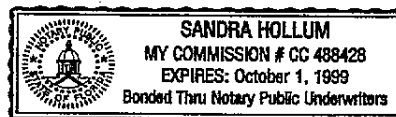
