The undersigned, acting as incorporator does hereby form a corporation for profit under the FLORIDA GENERAL CORPORATION ACT, and adopt to these Articles of Incorporation.

ARTICLE ONE

The name of this corporation is NETWORK COMMUNICATIONS ELECTRONICS CORP., 5775 So. Rovon Point, Lecanto, Florida 34461.

ARTICLE TWO

The period of existence of this corporation shall be perpetual.

ARTICLE THREE

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, county, territory or nation.

ARTICLE FOUR

The maximum number of shares or stock that this corporation is authorized to have outstanding at any one time is 7000 shares of common stock, each having a par value of Fifty Cents (\$1.00) per share.

ARTICLE FIVE

No officer, or director or shareholder shall be personally liable for any debts of this corporation.

ARTICLE SIX

ARTICLE SEVEN

There shall be one director on the initial Board of Directors, whose name and street address is:

The number of directors may be increased or decreased by the By-Laws and need not be residents of the State of Florida or shareholders of the corporation.

#### ARTICLE EIGHT

#### ARTICLE NINE

The By-Laws of this corporation may provide for a restriction on the transfer or encumbrance of the shares of stock of this corporation, and may also provide for more than a majority affirmative vote on any action of the directors or shareholders of this corporation.

#### ARTICLE TEN

These Articles of Incorporation shall be effective immediately upon the filing of such Articles, and approval thereof by the Florida Department of State.

#### ARTICLE ELEVEN

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors and the shareholders.

#### ARTICLE TWELVE

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation, provided

however that the By-Laws shall provide the manner for adopting any amendments, and the By-Laws may require greater than a majority affirmative vote of the directors or shareholders to adopt any amendments. Amendments to these Articles may be adopted at any regular or special meeting, in accordance with the By-Laws.

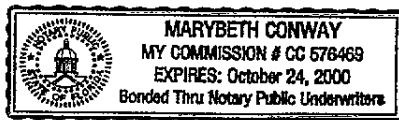
