## ARTICLES OF INCORPORATION

The undersigned, desiring to form a corporation under and pursuant to the laws of the State of Florida, for the purposes hereinafter stated, hereby make, subscribe and acknowledge and file with the Secretary of State of Florida, these Articles of Incorporation, as follows:

#### I. NAME.

## XIII. BYLAWS.

In furtherance and not in limitation of the powers conferred by the laws of the State of Florida, the Board of Directors are hereby authorized to adopt, alter, amend or repeal bylaws at their pleasure, so long as such bylaws are in accordance with the laws of the State of Florida.

## XIV. SHAREHOLDERS QUORUM AND VOTING.
