CERTIFICATE OF INCORPORATION OF C & E LAWN CARE, INC.

For the purpose of forming a corporation for profit under the general laws of the State of Florida, it is respectfully requested of the Secretary of State the approval for under the following Articles.

The name of this corporation shall be <u>C & E Lawn Care</u>, Inc. and it's principal place of business shall be at 18820 N.W.41st Avenue, Miami, Fl 33055 with the right to change and move said principal place of business and establish such other offices and place of business within or without the State of Florida as the Board of Directors may from time to time deem proper.

ARTICLE II

The general purpose and nature of the business of this corporation is to engage in any activity or business with any or all powers for any or all purposes determined convenient or necessary by the Board of Directors as permitted under the laws of the United States and the State of Florida except as may be restricted under these Articles and it's By-laws.

ARTICLE III

The total authorized capital stock of this corporation shall be one hundred shares of Common Stock with no par value. All of such stock shall be issued fully paid and nonassessable at and for such consideration, whether the same cash, services fixed rendered, or otherwise and upon such terms and conditions as may be fixed by the Board of Directors of this Corporation.
