The subscribers to these Articles of Incorporation are natural persons over the age of 18 years, duly licensed by the State of Florida to conduct the practice of medicine, who present these Articles for the formation of a corporation under The Professional Service Corporation Act and other applicable laws of the State of Florida.

EFFECTIVE DATE

ARTICLE I: NAME

01-01-98

The name of this Corporation is MUNIRA ZAFAR, M.D., P.A. with an initial principal office and mailing address of 816 W. Oak Street, Kissimmee FL 34741.

ARTICLE II: TERMS OF EXISTENCE

This Corporation shall commence as of January 1, 1998, and shall have perpetual existence.

ARTICLE III: NATURE OF BUSINESS

This Corporation may engage in the practice of medicine under the laws of the State of Florida through individuals authorized by that law to render such services as individuals.

In furtherance of the above purpose, the Corporation shall have the power to do the following:

1. To invest the funds of the Corporation in real estate, mortgages, banks, or any other type of investment, and to own real and personal property to be used for the rendering of medical services.

2. To do anything necessary and proper for the accomplishment of the purposes or exercise of the powers of the Corporation necessary or incidental to the protection and benefit of the Corporation, and in general, either alone or in association with other corporations, firms, or individuals, to carry on any lawful pursuit necessary or incidental to this accomplishment of the purposes or exercise of the powers of the Corporation.

ARTICLE IV: CAPITAL STRUCTURE

The total number of shares of capital stock authorized to be issued by the Corporation will be one thousand (1,000) shares of common stock of the same class, having a par value of no par per share. Each of the said shares of stock will entitle the holder thereof to one (1) vote at any meeting of the stockholders. None of the shares of the Corporation may be issued to anyone other than an individual duly licensed to practice medicine in the State of Florida.

ARTICLE V: INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of this 816 W. Oak Street, Kissimmee fl 34741; and the name of the initial registered agent of this Corporation at that address is MUNIRA ZAFAR, M.D. The Board of Directors may, from time to time, move the principal office to any other address.

ARTICLE VI: BOARD OF DIRECTORS

There shall be a Board of Directors of this Corporation which shall consist of not less than one (1). Except for the number constituting the initial Board of Directors, the number of directors may be increased or diminished from time to time by the By-Laws adopted by the Shareholders.

ARTICLE VII: INITIAL BOARD OF DIRECTORS

The name and street address of the initial Board of Directors of this Corporation, who, subject to these Articles of Incorporation and the laws of the State of Florida, shall hold office until the first annual meeting of the Shareholders or until his successor is elected and qualifies, or until his registration, removal from office or death is:

This Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE XI: AMENDMENT


The Corporation reserves the right to amend or repeal any provisions contained in these Articles or any amendment hereto, any right conferred upon the Shareholders are subject to this resolution.
