To Whom It May Concern,

In December of 1997, I hired a paralegal group to file paperwork to establish my corporation and requested that it be effective January 1, 1998. I stressed to Mr Padilla that on the advice of my accountant, we wanted it to go into effect the first of the year.

Not long after I received the corporation papers, I received a request for my annual report. I called Mr Padilla's office and asked whether anything could be done to correct the effective date. His secretary said he would call me back. Not long after that conversation I received a letter from the Internal Revenue Service stating that they were considering my corporation effective Jan 1, 1998 so assumed that the problem had been solved.

Since I have now received another request for my annual report, I realize that the letter from the IRS is not connected with the Department of State and that Mr Padilla did not correct the effective date. I telephoned your office and was told that I should write a letter of explanation and send the \$150.00 filing fee in the hope that you will accept it and not charge me the additional fine of \$400. Mine is still a very small company and the fine will create a real hardship for me.

I hope that, under the circumstances, you will accept the filing fee of \$150 which is enclosed. If not, please let me know. In the future, I will consult a real attorney instead of a paralegal and hopefully will not have these kinds of problems again.
