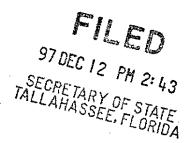

ARTICLES OF INCORPORATION

OF

R.L.W.& COMPANY, INC.

ARTICLE I -- NAME

The name of this corporation is R.L.W. & Company, Inc.

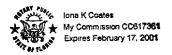
