The undersigned natural person, who is licensed or otherwise legally authorized to practice the profession of accounting in the State of Florida, hereby forms a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of this corporation shall be: I. JONATHAN HASKEL, CPA, PA. The address of the principal office of this corporation shall be 1761 W. Hillsboro Blvd., Suite 404, Deerfield Beach, Florida 33442, and the mailing address shall be the same.

ARTICLE II - NATURE OF BUSINESS

The purpose of the Corporation is:

A. To engage in the practice of accounting as a professional certified public accountant corporation and to carry on services incident thereto. The practice of accounting is the sole and exclusive professional service to be rendered by the corporation.
