The undersigned incorporators, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

Article I. NAME

Article II. PLACE OF BUSINESS

The principal place of business of this corporation shall be 2800 - 4th Street, North, Suite 166, St. Petersburg, FL 33704.


Article IX. AMENDMENT


