#### **ARTICLES OF INCORPORATION**

The undersigned incorporator for the purpose of forming a corporation under the Florida Business Corporation Act hereby adopts the following Articles of Incorporation.

# **ARTICLE I**

The name of the corporation shall be: CALIFORNIA DINER, INC.
