# ARTICLES OF INCORPORATION OF DESOTO INSURANCE COMPANY

The undersigned incorporators to these Articles of Incorporation, natural persons over the age of 18 years, competent to contract and the majority of whom are citizens of the United States of America, hereby form a stock insurance company under the laws of the State of Florida.

#### ARTICLE I - NAME


