ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these Articles of Incorporation, a Ratural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

<u>ARTICLE I</u>

The name of the corporation is:

ARTICLE II

The corporation will engage in any activity or business permitted under the laws of the United States and the State of Florida.

The corporation is authorized to have outstanding one class of stock designated as common stock.
