

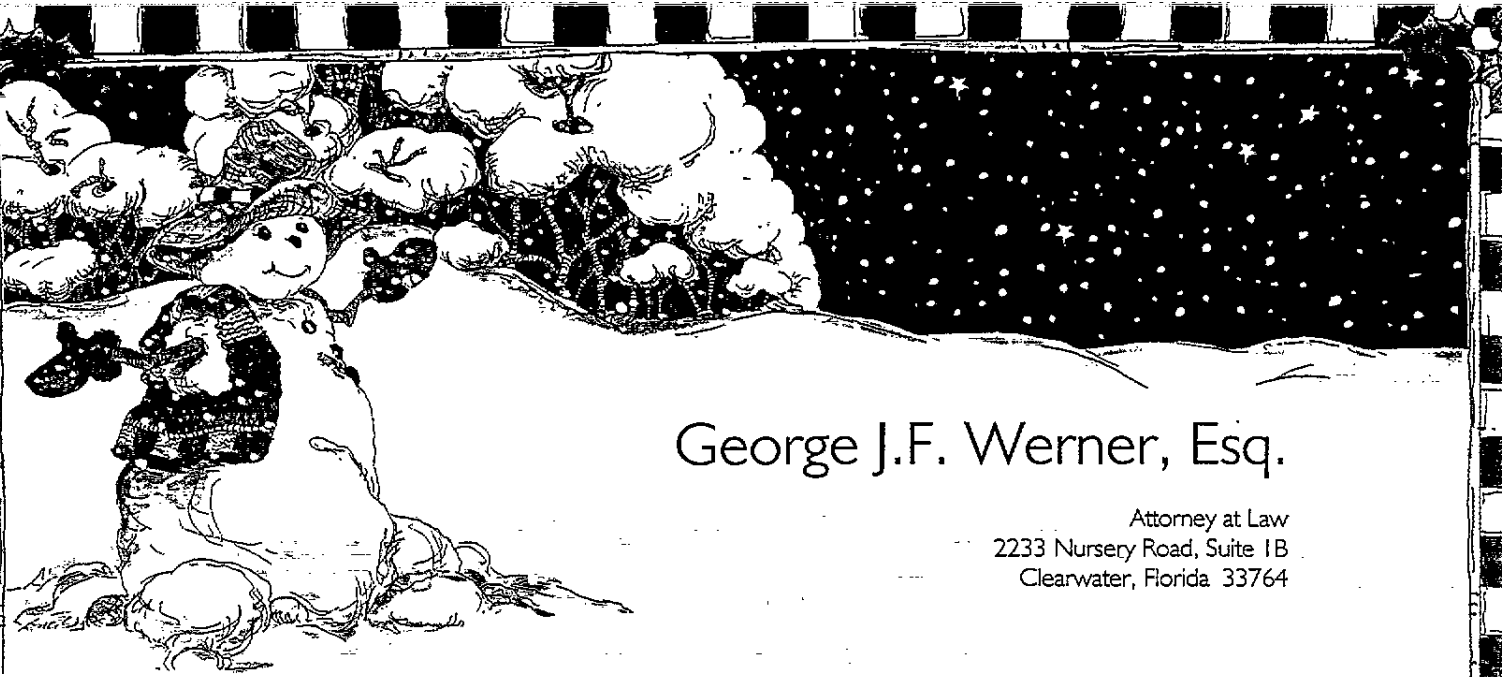



ARTICLE I; NAME

The name of this corporation shall be ADVANCED COMMUNICATION &
CONSTRUCTION, INC. ARTICLE II; DURATION

The corporation shall have a perpetual existence.

ARTICLE III; PURPOSE

The purpose of this corporation is to engage in the business of
any lawful purpose.

ARTICLE IV; STOCK

The maximum number of shares which this corporation is authorized
to have outstanding at any time is ten thousand shares of common stock
at ten cents par value per share.

ARTICLE V; BOARD OF DIRECTORS

The initial Board of Directors shall consist of three members.
The number of directors may be increased or decreased from time to time

right to subscribed or purchase from the corporation any shares of its stock of any class or classes.



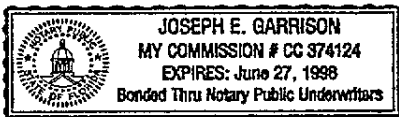
