ARTICLES OF INCORPORATION

OF

BROADLINE PRODUCTS, INC.



The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be:

BROADLINE PRODUCTS, INC.

ARTICLE II PRINCIPAL OFFICE

The mailing address of the initial principal office of this corporation is 1020 Newport Center Drive West, Deerfield Beach, FL 33442. The Board of Directors may, from time to time, change the street and post office address of the principal office of the corporation.

ARTICLE III PURPOSE

To engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV CAPITAL STOCK

This corporation is authorized to issue 100,000 shares of common stock.
