## ARTICLE I - NAME

The name of the corporation shall be NORMAN DIEHL ENTERPRISES, INC. The mailing address for the corporation is 4030 Dyer Lane, Sarasota, Florida, 34233.

#### ARTICLE II - DURATION

This corporation shall exist perpetually.

## ARTICLE III - PURPOSE

This corporation is organized for the following purposes:

to manufacture, purchase, or otherwise acquire, and to own,

mortgage, pledge, sell, assign, transfer or otherwise dispose of,

and to invest in, trade in, deal in and with goods, wares,

merchandise, real and personal property, and services of every
