ARTICLES OF INCORPORATION  
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of the corporation is D. B. Grasses Inc.

ARTICLE II - INCEPTION

The existence of the corporation shall begin on OCTOBER 28, 1997.

ARTICLE III - PRINCIPAL OFFICE
