CAPITAL STOCK**

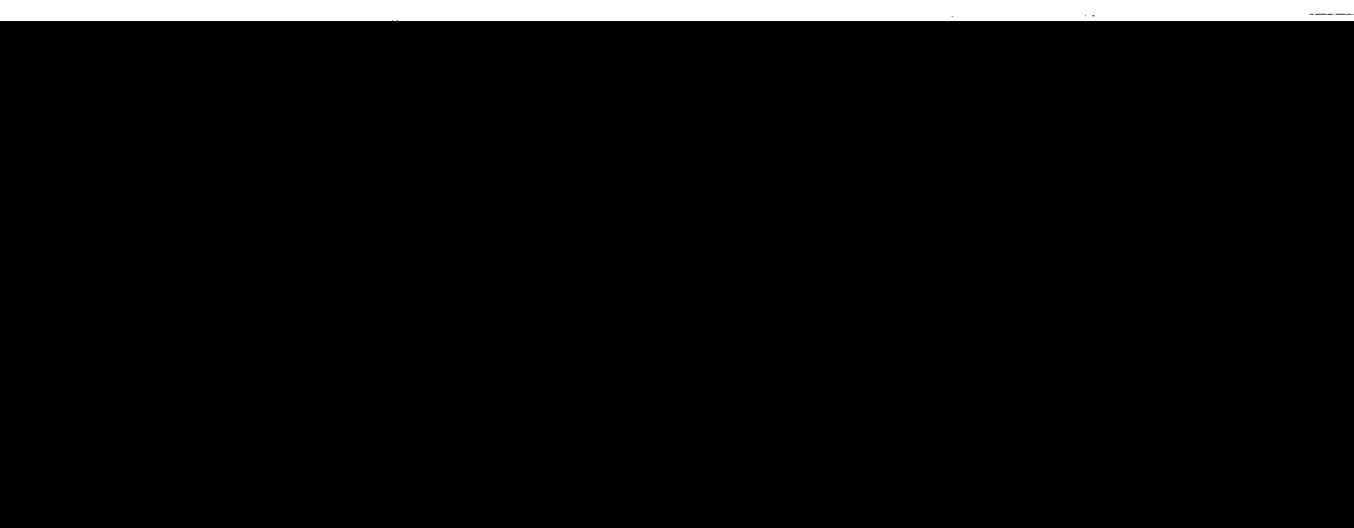
