ARTICLES OF INCORPORATION



OF

<u> Article I - Name</u>

The name of this corporation is LOST LAKES HOLDING CO., INC. and its principal office is located at 140 Lost Lakes Drive, Cocoa, Florida 32926.

Article II - Duration

This corporation shall exist perpetually. The date of commencement of corporate existence shall be the date these articles are filed with the Secretary of State.

Article III - Purpose
