FIRST: The name of this corporation is IOC Inc.

SECOND: Its registered office and principle office in the State of Florida is to be located at 3801 E. Osborne Ave, in the City of Tampa, County of Hillsbrough. The registered agent in charge thereof is Marcellas Lyles at the registered office of corporation.

It is the intention that the objects, purposes and powers specified in the Third paragraph hereof shall, except where otherwise specified in said paragraph, be nowise limited or restricted by reference to or inference from the terms of any other clause or paragraph in this certificate of incorporation, but that the objects, purposes and powers specified in the Third paragraph of this charter shall be regarded as independent objects, purposes and powers.
