The undersigned persons hereby associate for the purpose of becoming a professional association for profit under the laws of the State of Florida in compliance with Florida Statute §607.0202.

Article I

EFFECTIVE DATE
01-01-98

The name of the professional association shall be Taylor & Perez, P.A.

Article II

The mailing address of the principal office of the professional association shall be:

Article III

The purpose for which the professional association is being formed and the general nature of the professional association's business shall be legal services, as well as to engage in any other activity or business permitted under the laws of the State of Florida.

Article IV

The amount of capital stock of the professional association shall be One Thousand (1,000) shares of common stock with a par value of \$1.00 per share.

Articles V

The amount of capital with which the professional association will begin business will be no less than Five Hundred Dollars (\$500.00).

The entire voting power for the selection of directors and for all other purposes shall
