

ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article One: Name

The name of this Corporation ("Corporation") shall be "Natureland of Pinecrest, Inc."

Article Two: Principal Office

The principal place of business and mailing address of this Corporation shall be 9550 S.W. 67th Avenue, Miami, Florida 33156.

Article Three: Capital Stock

The number of shares of stock that this Corporation is authorized to have outstanding at any one time is one thousand (1000) shares having a par value of one dollar (\$1.00) per share.

Article Four: Initial Registered Agent and Address

The name and street address of the initial registered agent is: Harris Gubernick, 10160 SW 99th Avenue, Miami, Florida 33176.

Article Five: Incorporator

Article Six: General Provisions

A. The Corporation may transact business, borrow, lend or otherwise deal or contract with the Corporation to the full extent and subject only to the limitations and provisions of the laws of the State of Florida and the laws of the United States.

B. The Corporation shall indemnify each director and officer of the Corporation from and against all or any portion of any expenses reasonably incurred by him in connection with or arising out of any action, suit or proceeding in which he may be involved, by reason of his being or having been an officer or director of the Corporation (whether or not he continues to be an officer

or director at the time incurring such expenses), to the full extent permitted by and subject only to the limitations and provisions of the laws of the State of Florida and the laws of the United States. This provisions shall be in addition to any other rights to which those indemnified may be entitled under any By-laws, agreements, vote of shareholders or disinterested directors or otherwise, both as to action in his official capacity and is to continue to any person who has ceased to be a director or officer, and shall inure to the benefit of the heirs, executors and administrators of such person.

The undersigned has executed these Articles of Incorporation this 9 day of December, 1997.


