We are in receipt of the Profit Corporation Annual Report for 1998 assessing the annual fee of \$150 plus a late filing penalty of \$400 for a total of \$550. We are enclosing this completed report with payment of \$150 and respectfully requesting an abatement of the \$400 late filing penalty assessed.

Mr. Shawn Logan from your office advised us to write to you requesting an abatement of this penalty based upon reasonable cause.

This corporation was established at the very end of December, 1997 and is in it's first year of operation. Upon consultation with the Florida Department of Revenue, and other outside consultants, we were incorrectly advised that only a Florida Corporate Income/Franchise & Emergency Excise Tax Return had to be filed. As an accountant in New York, we relied upon this information in the preparation of all tax and legal filings with the State of Florida. A timely filed corporate tax return was filed. However, we were totally unaware of this requirement regarding the annual report until it was received by us from the State of Florida. Furthermore, this report indicates that this was a second notice. Our records indicate that no first notice was ever received. Otherwise, we would have responded promptly. Since the sole officer of this corporation is a professional golfer playing overseas, all mail has been forwarded to us. This is the first indication that this report has not been filed and the first notice that we received from Florida. We have taken steps to ensure compliance of this filing requirement for the future. We believe that it would be inequitable to assess this penalty based upon reasonable cause.





Based upon my conversation with Mr. Logan from your office, we are submitting the annual report with the filing fee of \$150 and respectfully requesting that the late payment fee of \$400 be abated.
