**ARTICLES OF INCORPORATION
OF

ARTICLE ONE - NAME

The name of the corporation is PROFESSIONAL SEWER STUDIES, INC.

ARTICLE TWO - DURATION

This corporation shall have perpetual existence.

ARTICLE THREE - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business..

ARTICLE FOUR - CAPITAL STOCK

This corporation is authorized to issue ten thousand (10,000) shares of one dollar (\$1.00) par value common stock.
