ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is 103RD ST. PAWN & CHECK CASHING, INC. and its principal place of business is 3161-4 St. Johns Bluff Road South, Jacksonville, Florida 32246.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing upon the filing of these articles of incorporation with the Secretary of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - STOCK

This corporation is authorized to issue 1,000 shares of one dollar (\$1.00) par value common stock.

ARTICLE V - PREEMPTIVE RIGHTS

There shall be no preemptive rights in connection with the issue of new stock in the corporation.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE X - RESTRICTIONS ON TRANSFER OF STOCK

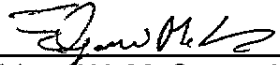
Shares of capital stock of this corporation shall be issued initially to the following person and in the amount set opposite his name:

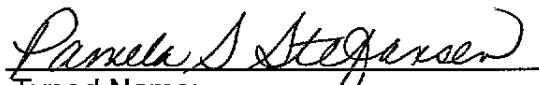
