ARTICLE ONE

The name of the corporation is **Jet Fleet International, Inc.** The principal address of the corporation is: **221 NW 35th Court, Fort Lauderdale, Florida 33309.**

ARTICLE TWO

The period of duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.
