ARTICLES OF INCORPORATION

OF

I FREMERALDS COASTS PROPERTY DEVELOPMENT; INC.

ARTICLE I - NAME:

The name of this corporation is: EMERALD COAST PROPERTY

DEVELOPMENT, INC. hereinafter referred to as the "Corporation".

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE:

The Corporation is organized for the purpose of engaging in the Construction Business and for the purpose of transacting any or all other lawful business not inconsistent with the Laws of the State of Florida.
