ARTICLES OF INCORPORATION

OF

NIINIVAARA TECHNOLOGIES, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this Corporation is NIINIVAARA TECHNOLOGIES, INC.

ARTICLE II - PURPOSE

This Corporation is organized for the purpose of transacting any and all business permitted under the laws of the State of Florida and the United States of America.

ARTICLE III-CAPITAL STOCK
