

ARTICLES OF INCORPORATION

OF

RENE & LEONE, P.A.

The undersigned hereby makes, subscribes, acknowledges and files these Articles of Incorporation for the purpose of forming a Corporation under the laws of the State of Florida.

ARTICLE I

Name

The name of the Corporation is to be: RENE & LEONE, P.A.

ARTICLE II

Duration

This Corporation shall have perpetual existence.

ARTICLE III

<u>Purpose</u>

This Corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States or of this State, more specifically set out as follows:

- 1. To perform all services in the practice of public accountancy as defined in LAWS AND RULES CHAPTER 473 OF THE FLORIDA STATUTES AND RULE CHAPTER 61H1, FLORIDA ADMINISTRATIVE CODE;
- 2. To transact any lawful business for which Corporations may be incorporated under the Florida

 General Corporation Act or engage in any other trade or business which can, in the opinion of

the Board of Directors of the Corporation, be advantageously carried on in connection with an auxiliary foregoing business.

3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE IV

Capital Stock

Incorporation

Indemnification
