ARTICLE I. NAME

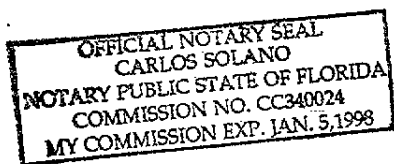
