OF

The Undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

*ARTICLE I- NAME*

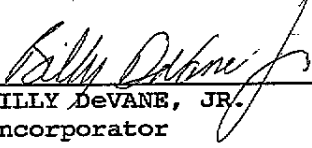
ARTICLE VIII-INDEMNIFICATION

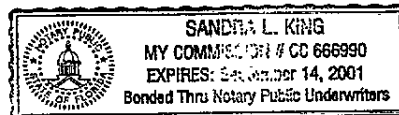
